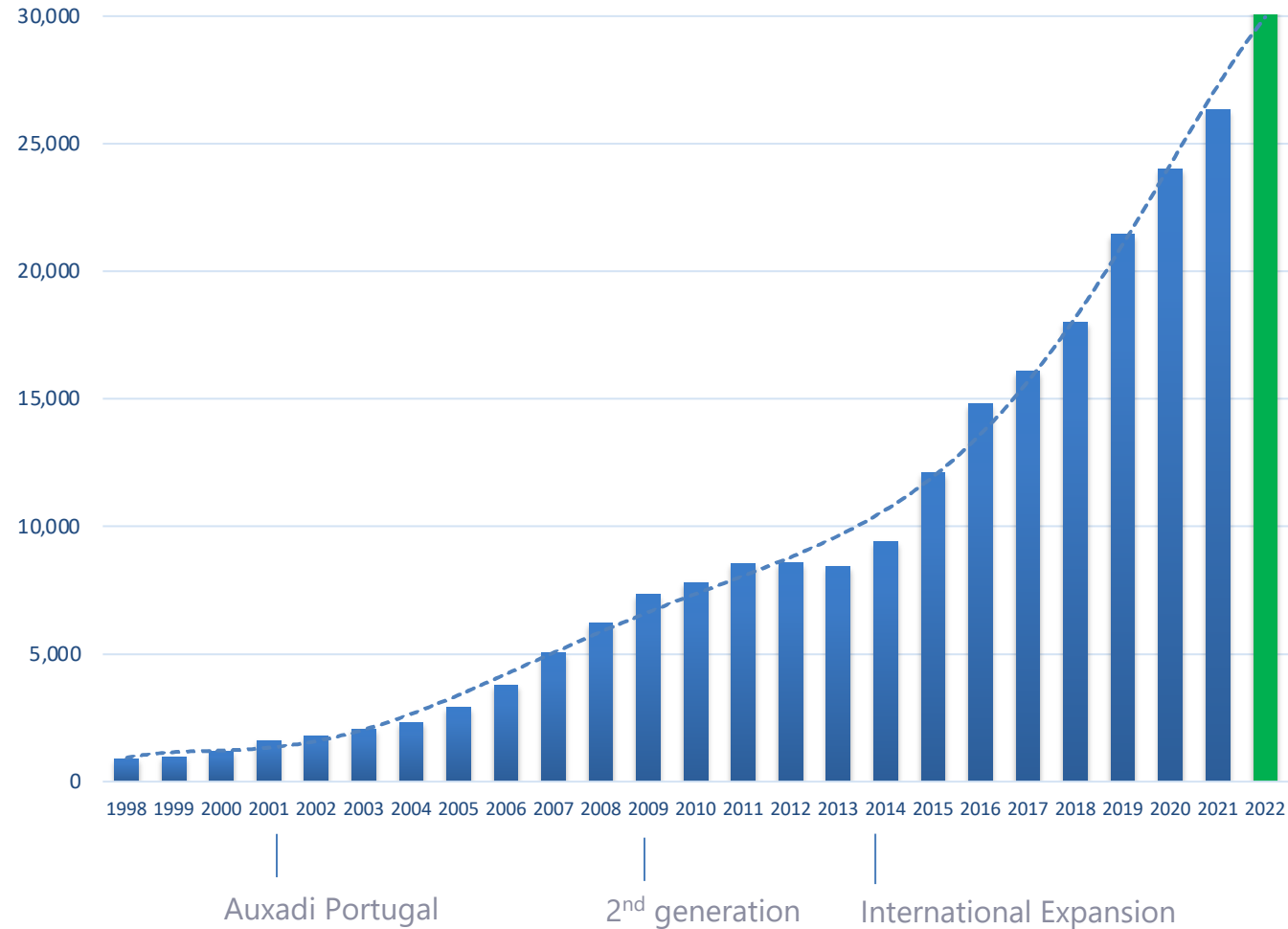

Revenue trend in Euros



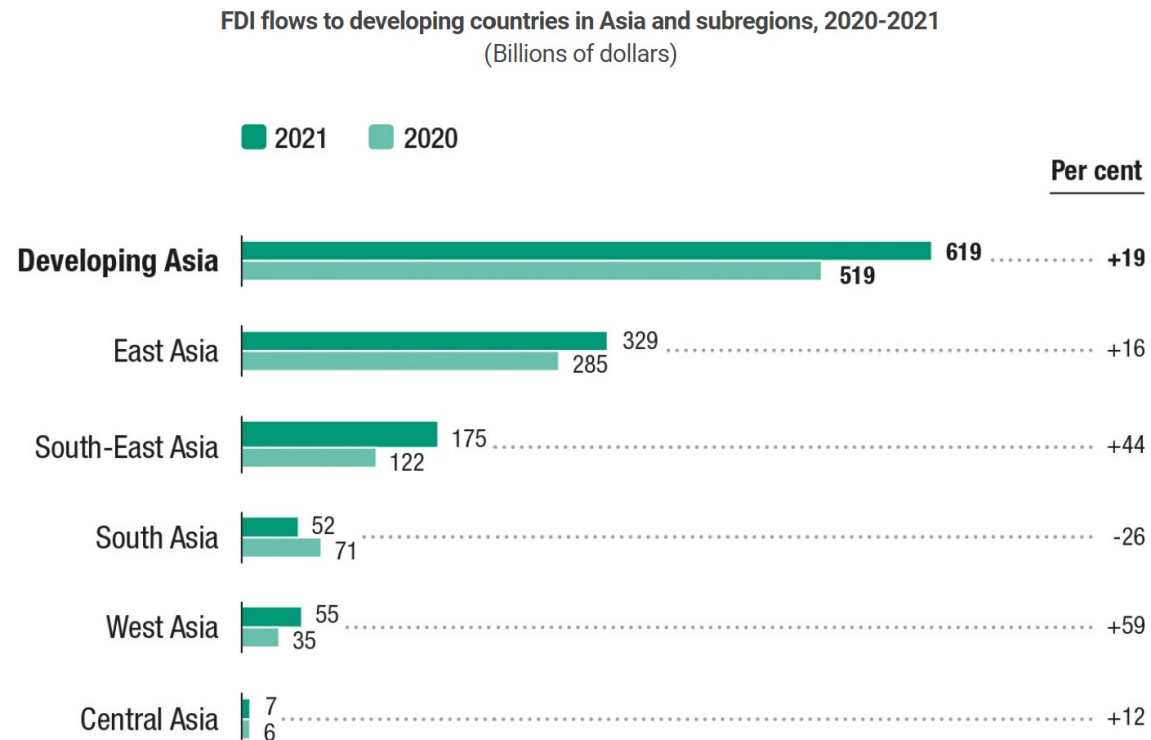
